WARM-UP WITH CONFIDENCE

As a coach, the minutes before your team performs can be filled with nerves and the pressure to typically squeeze the run-through into a 5-minute practice. We are adopting a 5-Step system to ensure that your team has ample time to stretch, warm-up stunts and mark formations, run through tumbling passes, practice their routine full-out, and have a water break – all before they reach the performance mat!

- 1) Stretching
- 2) Stunt Warm-up
- 3) Tumbling Strip
- 4) Full-Size Floor Run-Through
- 5) Water

PRIORITY SEATING

No more pushing to get to the front of the bleachers! Directly in front of the performance mat is a special section exclusively for the parents and fans to watch their team perform their routine. When their team is on, they have front row seats! Coaches will also be seated front and center!

We ask that spectators move quickly in and out of the seats so we can run on time all day! Fans must remain seated and keep signs down.



PERFORMANCE FLOOR

We will have a 42'x52' competition floor for all teams to compete on.

TEAM REQUIREMENTS

Little Loop/Youth Football: Maximum total routine time of 3 minutes.

Recreation/School: Maximum total routine time of 2 minutes, 30 seconds.

College and All Stars: Maximum total routine time of 2 minutes, 30 seconds.

REGISTRATION

First team to register, last team to compete in each division!!! Complete the registration form, as you would like it to appear in the program, and for the announcer. If you know you have school/all star conflicts please note that on the roster form so that we can avoid a conflict with the teams' performance times. Send one form of payment from school/group/gym, multiple individual checks will not be accepted. School purchase orders are accepted.

Distribute copies of the **NY ICON REVOLUTION** release form to each of your cheerleaders. These forms must be turned in at the event registration, do not mail them to NY ICON REVOLUTION prior to the event. Thank you.

A confirmation packet will be available on-line October 11th.

Please Note:

There is a limit of 2 coaches per team allowed free into the competition. Coaches will receive admission wristbands. Lost wristbands cannot be replaced. Additional coaches, team moms, etc. will need to enter at the spectator entrance and pay admission.

Division changes requested after the performance order is posted will be charged a \$100 change fee to be paid in full prior to the competition.
